

- aa. To carry out and promote coordination, mobilization and resourcing for community development.
- bb. To raise funds and operate projects for training and consultancy on community development, education, HIV/AIDS, the environment, children and youth development and entrepreneurship development.
- cc. To organize, host, and/or participate in local and international workshops, study groups, seminars and conferences aimed toward the achievement of the objectives of the Trust.
- dd. To organize, establish and operate projects for the promotion and amelioration of the spiritual, economic, and social welfare of vulnerable persons, families and communities, especially the marginalized groups, including, without limitations, orphans, street children, handicapped, widows, the helpless elderly and the homeless.
- ee. To promote peace, conflict resolution and reconciliation in families and society at large.

- ff. To undertake all activities necessary to promote and secure the institution of the family and to disciple and nurture godly families by example, precept, study, training, counseling and other commendable means.
- gg. To support and operate social, cultural and economic activities including but not limited to, schools, hospitals, children centres, hospices, services for the elderly and other socially and economically marginalized groups.
- hh. To provide basic life-skills and financial stewardship training for children and young adults
- ii. To engage in the work of relief, rehabilitation and resettlement of displaced persons and victims of disasters, among others.
- jj. To collect, purchase, store, transport, deliver, distribute and donate all kinds of items, supplies, equipment, materials and goods of all kinds for use in relief, rehabilitation, education, spiritual enrichment, development or the use in ancillary activities which may be conveniently carried on in conjunction with the Trust's objectives.
- kk. To train and sensitize communities, project beneficiaries and other stakeholders on the needs and challenges of vulnerable children and young adults.
- ll. To originate, support, supply, administer, promote, and finance institutions, organizations, projects and programmes concerned with the work of relief, rehabilitation, development, education and medical services.
- mm. To make use of the media for the cause of peace, reconciliation, education, spiritual enrichment, and cooperation within and across families and communities.
- nn. To create and establish agricultural development and income-generating enterprises to support the objectives of the Trust.
- oo. To carry out collaborative research and partnerships on critical issues affecting vulnerable children, young adults, widows, the disabled, and other vulnerable people.
- pp. To promote self-reliance and facilitate individual initiative and enterprise in developing income-generating activities with a view to boosting the welfare of households, families and communities.
- qq. To engage in activities to improve the physical quality of life through improving their levels of agricultural food production, health, education and income.



- rr. To promote the start up and development of local churches and the communities in which they serve.
- ss. To adopt such means of making known the activities and the services of the Trust or its projects as may seem expedient, including, but not limited to, advertising in the press, on radio, television, brochures, newsletters, e-mail, websites, and by other lawful means.
- tt. To receive and administer gifts, offerings, grants and/or other contributions for the work of the Trust.
- uu. To solicit, collect and receive endowments, devises, bequests, and donations of all kinds of property for its own use, or in trust, for carrying out, or which would assist in carrying out, the objectives and purposes of the Trust.
- vv. To take such steps by personal or written appeals, public meetings or otherwise as may from time to time be deemed expedient for the purpose of procuring contributions to the funds of the company which have for their object the raising of money for the purposes of the Trust.
- ww. In compliance with Indian law, to apply to any international bodies, governments or authorities, national bodies, public organizations, corporations, companies or persons for and to accept grants of money, land, donations, gifts, subscriptions and other assistance with a view to promoting the objectives of the Trust and in taking any gift or property, to take the same subjects to any special trust which may be prescribed by the donor thereof.
- xx. To purchase, own, or otherwise acquire and to hold, licence, maintain, work, exploit, farm, cultivate, use, develop, improve, sell, let, surrender, exchange, hire, convey or otherwise deal in land, real property and natural resources wheresoever situated, and in any interest, estate and rights in any real, personal or mixed property and any franchises, rights, licenses or privileges, and to collect, manage, invest, reinvest, adjust, and in any manner to dispose of the income, profits, and interest arising there from.
- yy. To acquire, own, lease, sell, let out on hire, administer, manage, control, operate, construct, repair, alter, equip, furnish, fit out, decorate, improve, dispose of, and otherwise undertake and deal in engineering and construction works, buildings, projects, offices and structures of all kinds.
- zz. To improve, manage, develop, sell, let, exchange, invest, reinvest, settle, grant licences, easements, options, servitudes and other rights over, or otherwise deal with all or any part of the Trust's real property, intellectual property, personality, and any of the Trust's rights, interests and privileges (present and future).



- aaa. To borrow or raise money that may be required by the Trust upon such terms and in such manner as the Trust shall think fit, including but not limited to, issuance of promissory notes, bills of exchange, cheques, warrants, debentures and other instruments.
- bbb. To enter into, carry on and participate in financial transactions and operations of all kinds, including, but not limited to, to open and operate accounts with any Bank or Banks and to draw, make, accept, endorse, discount and execute promissory notes, bills of exchange and other negotiable instruments.
- ccc. To appoint, engage, employ, maintain, provide for and dismiss employees, officers, attorneys, experts, consultants, and agents of the Trust in India, and to remunerate or compensate them at such rate and in such manner as the Trust deems fit.
- ddd. To partner with local churches, local communities, local groups, local people, and/or other organizations in India and elsewhere in carrying out any or all of the above objectives.
- eee. To do all such other things as are consistent and/or conducive to the attainment of the above objectives.
- fff. To glorify God through Jesus Christ in the operation of the Trust and the carrying out of any or all of the above objectives.

5. BENEFICIARIES:

The trust is non-political, non-sectarian organization and its services and benefits shall be open to all people irrespective of caste, creed, social background, community or religion and shall have a national character.

The activities of the Trust may be carried out anywhere in India. No activities of the Trust shall be carried out anywhere outside India.

6. TRUSTEES:

The number of Trustees shall not be less than Three and not more than Seven.

All the Trustees holding office at any point of time shall be referred collectively as the Board of Trustees.



THE FOLLOWING PERSONS CONSIST THE BOARD OF TRUSTEES:

1. **[Kanukolanu Sudhakar]** (Chairman and Managing Trustee of the Trust).
2. **[Dr. Sujai Kumar Suneetha]**
3. **[Vivian Issac Anthony]**

The Board of Trustees shall have the power to co-opt one or more persons to the Board of Trustees, subject to the limits prescribed herein. The term of Member Trustees shall be Three years from the date of their co-option and they are eligible for renewal of their term on its expiry.

The Trustees may, by resolution, appoint one among them to be the Chairman and Managing Trustee for such time or as long as he continues to be a Trustee of these presents. On the death, retirement, resignation, refusal or incapacity of the Managing Trustee, the remaining Founder Trustees shall be appointed as the Managing Trustee of the Board of Trustees, or shall elect a new Managing Trustee.

From among the Trustees, the Board shall nominate one person as the Managing Trustee.

The Board shall also have the Power to assign Trustees with any other designation. The Period for which they shall hold such office shall be specified by resolutions of the Board nominating them.

The First Managing Trustee shall be [Kanukolanu Sudhakar].

No person shall be eligible to be appointed as a Trustee and a Trustee shall cease to hold office if the person :-

- (i). becomes a person of unsound mind,
- (ii) is convicted of an offence involving moral turpitude,
- (iii) has been adjudged insolvent,
- (iv) is, or becomes deaf, mute or is suffering from a bodily infirmity which shall render him unfit for active work,
- (v).is otherwise disqualified to act as a Trustee according to the provisions in the India Trust Act, 1982, or any other Acts.

All vacancy in the office of the Trustees, due to death/resignation may be filled up by the continuing Trustees by a decision of the Board of Trustees. The vacancy shall be filled within 60 days from the date of creation of such vacancy.



7. BOARD OF TRUSTEES:

The management of the affairs of Trust shall always be in the Board of Trustees and it shall have all powers which are necessary for carrying out the objects and purpose of the Trust and for administering the activities of the Trust.

The Board shall be the ultimate authority to review the functions and performance of the Trust.

The Trust may adopt by-laws, constitution, rules and regulations as approved by the Board from time to time and amendments made to it shall abide by the same for the good and efficient administration of the Trust.

8. PROCEEDINGS OF THE BOARD:

The Board shall meet as often as necessary to transact the business relating to the Trust.

A minute's book shall be maintained for recording resolutions passed at Board meetings. The minutes of each meeting shall be duly authenticated by the Chairman of that Meeting.

Every Trustee present at any meeting shall sign his/her name in an attendance book maintained for that purpose.

In all matters pertaining to the Trust, the decision of the Majority of the Trustees shall be final. In case of the tie of votes, no decision shall be made until a majority is attained.


The Board shall have the power to delegate any of its powers to any of the Trustees to the extent it considers necessary or expedient.

9. POWERS OF THE TRUSTEES:

For the furtherance of the objects of the Trust and in accordance with the provisions of Section 13 (1) (d) and read with Section 11 (5) of the Income Tax Act, 1961 pertaining to use of the Trust Funds, for the time being in force, the Trustees will have the following powers:

(i). To accept any donation, contribution, endowment, grant or subscription in cash or in kind from any person, body corporate or body of person or trusts with or without conditions.


(ii). To apply the whole or part of the income of the Trust and accumulation thereof or whole or part of the Trust Fund to any one or more of the objects of the Trust as the Trustees may at their discretion decide from time to time.



- (iii). To sell, dispose of, alienate or otherwise deal with any property comprising the Trust Fund.
- (iv). To open accounts in the name of the Trust, and / or instructions run / conducted by the Trust with a bank or banks and to operate such accounts and to give instructions to the bank and to and to provide for opening and operation of such accounts by one or more of the Trustees. The Trustees will have the power to close such bank accounts.
- (v). To make, vary, alter or enact or modify schemes, rules and regulations for carrying out the objects of the Trust and for the management of the affairs thereof and / or otherwise for giving effect to the objects of the Trust with the prior approval of the appropriate Commissioner of Income Tax.
- (vi). To raise loans and advances for the purpose of the Trust and to repay such loans and advances from out of the income of funds of the Trust.
- (vii) To purchase or acquire movable or immovable properties including vacant sites and or buildings and to construct, renovate or demolish buildings or structures for the purpose of the Trust.
- (viii). To let out, rent or hire any of the landed properties of the Trust or take on lease, rent or hire any properties for the use and purposes of the Trust.
- (ix). To accept from India or abroad including donations, sponsorships, fees, grants and aids in money, in kind, landed property or in any other mode either by way of addition to the general corpus of the Trust or for being applied on any one or more of the specified objects of the Trust or for the general purpose of the Trust.

10. POWERS OF THE MANAGING TRUSTEE:

- (i). The Managing Trustee shall be Trustee with primary oversight responsibility of the Trust and its activities.
- (ii). All deeds, documents, papers, application shall be executed by the Managing Trustee representing the Trust.
- (iii). The operation of the Bank Accounts and management of all Trust assets shall be overseen by the Managing Trustee, in conjunction with the Field Director or other Trust leadership employed to manage the day-to-day affairs of the Trust.



11. APPOINTMENT OF ADVISORY BOARD:

The Board of Trustees shall have the powers to constitute, appoint and nominate an Advisory Board and such members shall be either from within the country or abroad and shall empower Board with powers to advise on

issues relating to the aims and objectives and the effective functioning of the Trust, and financial matters and projects of the Trust.

12. REMUNERATION TO THE TRUSTEES:

The Trustees are not entitled for any remuneration. But they shall however be entitled to receive out of pocket expenses incurred by them in the course of discharging the functions of the Trust. Further the income and funds of the Trust will be solely utilized towards the objects and no portion of it will be utilized for payment of Trustees by way of profits, interest and dividends of otherwise.

13. ASSETS AND FUNDS:

The Trust shall maintain Bank Accounts in its name and the same shall be operated by such person as the Board may resolve from time to time.

The Sum of Rs.10,000/-, initially contributed towards the corpus of the Trust is hereby acknowledged by the Trustees as having been received.

Such of the moneys of the Trust that cannot be applied immediately or at an early date for the purposes of the object shall be kept invested in such manner and in such modes as the Board may decide subject to regulations contained in the Indian Trust Act, 1882 and Income Tax Act, 1961. The Investment of the funds of the Trust shall be in accordance with provisions of Section 13(1)(d) read with Section 11 (5) of the Income Tax Act, 1961.

The Board shall have the power to release or otherwise dispose of any or all the investments from time to time in the interest of the Trust. The Board may utilize proceeds of such realization of disposal for any of the objects of the Trust and / or for reinvestment as provided above.

All investments shall be made in the name of the Trust. The Trustees authorized by the Board shall execute the necessary documents on behalf of the Trust and / or for reinvestment as provided above.

The income and funds of the Trust will be solely utilized towards the objects and no portion of it will be utilized for payment of Trustees by way of profit, interest divided, etc.



14. ACCOUNTS:

The Trustees shall cause true and accurate accounts to be kept of all monies received and spent and of all matters in respect thereof in course of management of Trust's properties or in relating to the carrying out of the objects and purposes of the Trust as well as of all assets, credits and effects of the Trust's properties.

The Accounting year of the Trust shall be the period starting on the first day _____ and ending on _____ 31st _____ next year. For the first year it shall end on 31st _____ 2013. The said accounts of the Trust shall get regularly audited by Chartered Accountants every year and presented to the Board by the Managing Trustee within Three months of the close of the financial year.

15. BORROWINGS:

The Trust can borrow funds for implementing or carrying out any of the objects and purpose of the Trust from any Banks, Financial institutions or private parties on security by mortgaging or pledging any of the immovable or movable properties of the Trust or without security of such interest and on such terms and conditions.

16. IRREVOCABLE:

The Trust formed is irrevocable and Trust will continue not with standing the death, retirement or resignation of any Trustees and the Trust will be continued with the remaining Trustees.

17. RESOLVING DISPUTES:

If thereby any doubt about interpretation of this Deed or about duties the matter shall be referred to an arbitrator chosen by a consensus among the Trustees and his decision shall be accepted.

18. DISSOLUTION:

If the objects of the Trust should fail or the Trustees are unable to continue the Trust, the Trust Fund will not revert either to the founders or to any one else. The Trust Fund and assets should only be applied for any other similar Trust with the same or similar charitable objects for public benefit, such Trust being chosen by the last Trustee.

19. PROCEEDING OF THE TRUST:

Any defect in the constitution of the Trust shall not invalidate its proceedings.



20. AMENDMENT OF THE TRUST DEED:

The Trust Deed may be amended by the Trustees to the extent permitted by the applicable laws of India.

21. SAVING CLAUSE:

If the object or any of the powers or any provision in the Trust Deed is inconsistent with requirements of law relating to Public Trusts or Trusts eligible for exemption under the Income-Tax Act, or any other direct tax law, such object, power to provisions will stand modified to the extent that they should accord with such law so as to continue to be eligible to be treated as a Public Charitable Trust.
